- Vendors are responsible for their tables, chairs, booths, displays, tents and any other material needed for their space as well as set up of their equipment. No electricity is available.
- You may begin setting up by 7:00 a.m. All vendors must be checked in 1 hour prior to the event start time of 9:00. After unloading, please park in the lot behind CCSD. **NO PARKING IS ALLOWED ON THE STREET.**
- All booths shall remain open until 3:00 p.m. Tear down must be completed by 5:00.
- Vendor must confine their activities to within their booth space. No strolling vendors are allowed; you may not walk around and distribute information or solicit to the public.
- Participation in our raffle is encouraged, but not required.

LIABILITY WAIVER:
